**Big Sky Care Connect Partners with Industry Leader [Health Catalyst](#)**

**Helena, Montana** - Big Sky Care Connect (**BSCC**), Montana's premier health information exchange (HIE), is partnering with [Health Catalyst Inc.](#) ("Health Catalyst," Nasdaq: HCAT), a leading provider of data and analytics technology and services to healthcare organizations, to provide clinicians throughout Montana access to [Health Catalyst's](#) technology and services to greatly advance data-informed healthcare improvement throughout the state.

By virtue of the partnership between **BSCC** and [Health Catalyst](#), Montana healthcare providers and their leadership can use data and analytics to save millions of dollars while simultaneously improving the overall health of individuals, families and communities throughout Montana.
